Notice is hereby given that the **Evidentiary Hearing** convened in the above-entitled matter on Wednesday, March 25, 2008, to consider the request of Dammeron Valley Water Works ("DVWW") to add a conservation rate to its tariff will continue with the Administrative Law Judge of the Public Service Commission of Utah on **Friday**, **June 13, 2008**, at 9:30 a.m. at the **Commission Chambers**, 197 East Tabernacle, St. George, Utah.

In this docket, DVWW originally proposed the following addition to its tariff:

<u>Conservation Water Rate (Monthly Rate)</u>
This rate would be for .45 Acre Feet annual consumption (400 gallons per day)

		on conservation tariff customers only)

## Notes:

- 1. The conservation tariff will be applied to new subdivisions platted after the tariff is approved. Existing customers may apply to convert to the conservation tariff but once converted, will not be allowed to convert back to their original tariff rate.
- 2. All customers owning irrigation shares may be required to discontinue irrigating if required to do so by Dammeron Valley Water Works. The irrigation water is our drought insurance as well as a buffer when emergencies occur in the system.
- 3. DVWW may offer to customers from time to time the right to use water over and above their tariff allocation at the irrigation rate. This will generally be used to help landowners keep their native foliage healthy during times of extreme drought.

However, prior to and at hearing on March 25, 2008, DVWW proposed an additional bulk sale irrigation rate that had not been evaluated by the Division of Public Utilities ("Division") nor noticed for hearing. In addition, at hearing DVWW offered to make changes to its proposed tariff to address the concerns of those present at the hearing. DVWW agreed to work with the Division to re-draft its proposed tariff and to send adequate notice of the revised proposed tariff to each customer prior to continuation of the hearing. We expect said notice to issue to customers at least thirty days prior to the hearing noticed above.

In addition to the evidentiary hearing, a **Public Witness Hearing** will be held on **Friday, June 13, 2008, at 11:30 a.m.**, also at the **Commission Chambers, 197 East Tabernacle, St. George, Utah**, to provide customers an opportunity to make their views known to the Commission regarding the proposed revisions and additions to DVWW's tariff..
