Notice is hereby given that an **Evidentiary Hearing** in the above-entitled matter will be conducted on **Wednesday, March 25, 2008, at 1:30 p.m.**, with the Administrative Law Judge of the Public Service Commission of Utah in Room 451, Fourth Floor of the Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah, to consider the request of Dammeron Valley Water Works to add a conservation rate to its tariff. Specifically, if approved, the following rate would be added to Dammeron Valley's tariff and customers would be given the option of switching from their current water usage rate to the Conservation Water Rate:

Conservation Water Rate (Monthly Rate)

This rate would be for .45 Acre Feet annual consumption (400 gallons per day)

<u>Entitlement</u>	<u>Usage</u>	<u>Charges</u>
All customers	First 12,000 gallons	\$18.00 minimum monthly charge
on conservation	Next 12,000 gallons	\$2.00/1000 gallons (existing overage charge)
tariff	Over 24,000 gallons	\$3.00/1000 gallons (additional overage charge on conservation tariff customers only)

Notes:

1. The conservation tariff will be applied to new subdivisions platted after the tariff is approved. Existing customers may apply to convert to the conservation tariff but once converted, will not be allowed to convert back to their original tariff rate.
2. All customers owning irrigation shares may be required to discontinue irrigating if required to do so by Dammeron Valley Water Works. The irrigation water is our drought insurance as well as a buffer when emergencies occur in the system.
3. DVWW may offer to customers from time to time the right to use water over and above their tariff allocation at the irrigation rate. This will generally be used to help landowners keep their native foliage healthy during times of extreme drought.

**2008, at 2:30 p.m.**, also in Room 451, Fourth Floor of the Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah, to provide customers an opportunity to make their views known to the Commission regarding the addition of the proposed Conservation Water Rate.

Participants attending by telephone should then call the Public Service Commission five minutes prior to the beginning of the Evidentiary Hearing or Public Witness Hearing to ensure participation.
