CHANGES TO RECOMMENDATIONS MEMORANDUM EXHIBIT 1.0

After hearing the concerns of Pineview West Water Company (Pineview or the “Company”) and ratepayers Velma Reeder and Peter Turner, the Division of Public Utilities (DPU or the “Division”) wish to make the following changes to their Comments and Recommendations filed on January 20, 2009.

CHANGE ONE

Under the section of Exhibit 1.0, pages 4 and 5 “ADJUSTMENTS TO THE PROPOSED SPECIAL ASSESSMENT,” the Division wishes to make the following changes.

Exhibit 2.2 replaces Exhibit 1.3 and line 10, Ogden City Utilities has been modified: The following are the amended amounts:

CHANGE TWO

Under the section of Exhibit 1.0, page 5, ALLOCATION BASIS,” the Division recommends that the following changes be implemented: (See Exhibit 1.2, which is replaced by Exhibit 2.1.)

In addition to changing the amounts above, Pineview state that they currently have in excess of \$21,000 in past-due bills. The two aforementioned ratepayers both requested that the assessment be accelerated from monthly payments to one-half due immediately and the remainder due over the next six (6) months. The Division recommends changing the allocation from 12 equal monthly payments of \$51.23, effective January 1, 2009 to the following:

One-half of the one-time assessment of \$648.52 is to be due and payable on or before February 2, 2009 in the amount of \$324.26. The remainder of the assessment is to be paid in six (6) monthly equal payments, starting on March 1, 2009.

CONCLUSIONS:

The Division recommends:

- a) one-half of the amount of the special assessment, as listed on Exhibit DPU 2.1, to be assessed and due on or before February 1, 2009.
- b) the remainder of the assessment to be paid in six (6) monthly equal payments to commence on March 1, 2009
- c) that the amount of the special assessment for all connections belonging to Titan Development be credited against the amount Pineview owes Titan Development, not to exceed \$4,500.

The Division concludes that the recommended special assessment amounts as are just and reasonable.
