The Administrative Law Judge (ALJ) of the Commission held a duly noticed scheduling conference on Wednesday, October 21, 2009 in this matter. Darrin L. Jensen, of WaterPro, Inc. <b><u>Hearing-Public Witness portion</u></b>	<b>Tuesday, March 16, 2010 about 11:00 a.m. to 12:00 p.m., or beginning immediately following the main hearing</b> for a period of about one hour, before the ALJ of the Public Service Commission, Fourth Floor Hearing <b>Room 451</b> , Heber M. Wells State Office Building, 160 East 300 South, Salt Lake City, Utah.

The Company shall provide notice of the hearing to its customers no later than March 1, 2010.

Discovery turn-around time is 14 calendar days for requests served before February 16, 2010, and 7 calendar days for those served on or after February 16, 2010. Parties may move for an extension of time.

Individuals wishing to participate by telephone in the hearing should contact the Public Service Commission no later than two days in advance at (801) 530-6716 or 1-866-PSC-UTAH (1-866-772-8824). Individuals participating by telephone should call the Public Service Commission five minutes prior to the beginning of the hearing to ensure participation.
