Dear Commission:

I represent Moose Hollow Homeowners Association (“Moose Hollow”) an association that receives water service from Wolf Creek Water Company (“Wolf Creek”), a company regulated by the Utah Public Service Commission. It has come to the attention of Moose Hollow that entities related to Wolf Creek have recently declared bankruptcy and it is our understanding that Wolf Creek has failed to pay the annual assessment due on the water contract it holds with the Weber Basin Water Conservancy District (“Weber Basin”). As the Weber Basin contract is the sole source of the water supply for Moose Hollow, and other customers of Wolf Creek, we are concerned that this delinquency may result in interruption of water service to Moose Hollow despite the fact that Moose Hollow is current on all payments to Wolf Creek for water service.
