On April 6, 2012, Mountain Sewer Corporation filed in Docket No. 11-097-03 three applications seeking various forms of rate relief. Notice is hereby given that the Commission will hold a scheduling conference in the above-captioned matters commencing at **3:00 p.m., on Thursday, May 10, 2012, at Fourth Floor Room 401, Heber M. Wells State Office Building, 160 East 300 South, Salt Lake City, Utah.** At the scheduling conference, the Commission's hearing officer will establish the schedule and process for litigating the matters presented in Docket Nos. 11-097-01 and 11-097-03. Parties should come to the conference prepared to discuss the scope of the issues and potential litigation schedules. The Commission believes it has received all the information it needs to resolve Docket No. 11-097-02.

As of this date, the three matters captioned above are deemed to be consolidated. The practical effect of this action is that issues raised in the initial and supplemental complaints that have not yet been resolved among the parties will be litigated in the same hearings as the various rate proposals. In addition, all parties having previously intervened in any one of the three dockets will be considered to have intervened in each of them. While the parties have indicated the service quality issues initially reported have been largely if not wholly remedied, the Commission takes note of the billing and financial irregularities alleged in the supplemental complaint information. The Commission's prior request to the Division of Public Utilities ("Division") to investigate the complaint extends to the supplemental allegations. To the extent existing Mountain Sewer Corporation records allow, the Division's examination of the various rate relief proposals shall include investigation of the billing and financial irregularities the complainants have alleged.
