This firm represents Celtic Bank Corporation ("Celtic Bank") in general matters pertaining to property it owns in Weber County, Utah and serviced by Mountain Sewer Corporation ("Mountain Sewer"), specifically, the Edgewater Beach Resort property.


Only yesterday, May 14, 2012, Celtic Bank obtained, for the first time, information from the Commission regarding Mountain Sewer's applications for rate increases and the Scheduling Order and Notice of Hearings issued May 14, 2012. Celtic Bank learned at the same time that position statements on the applications were due to the Commission today from parties other than the Applicant. Celtic Bank therefore objects to the applications on the grounds that adequate notice of the applications, the statements deadline and the related hearing were not provided to it.

Moreover, because Celtic Bank did not receive notice until yesterday, it has not had time to adequately review Mountain Sewer's Application for Interim Rate Increase, Application for Special Assessment and Application for General Rate Increase, it states a general objection to all of Mountain Sewer's Applications and wishes to reserve time to speak at the hearing slated for May 21, 2012.

Celtic Bank also requests that it be timely provided with notice of all future hearings and filings made with the Public Service Commission which impact the Edgewater Beach Resort subdivision. Such notice can be provided to:
