By The Commission:

This matter is before the Commission upon the recommendation of the Division of Public Utilities ("Division"), dated April 16, 2012, concerning Certificate of Public Convenience and Necessity (CPCN) No. 2238. The Division recommends cancellation of the CPCN based on communication received from West Slope Water Company, Inc. ("West Slope"), indicating that it no longer needs its CPCN because it sold its water system to another entity.

On or about February 15, 2012, West Slope filed a letter with the Commission concerning its CPCN. According to its letter, the shareholders of West Slope approved a transfer of its water rights and water system to the Central Iron County Water Conservancy District ("Iron County") on September 10, 2010. Then, on or about November 24, 2010, title to the water rights and water system transferred from West Slope to Iron County. West Slope asserts that based on this transaction it no longer needs its CPCN.

ORDER

For the foregoing reasons, Certificate No. 2238, issued December 1997, is hereby canceled.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the Commission within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
