By The Commission:

On February 22, 2013, the Utah Public Service Commission issued an order, which, in part, denied WaterPro Inc.'s request for a fire service user fee, pending notice by WaterPro Inc. to its customers, pursuant to Utah Code Ann. § 54-3-3 (2010), and a hearing on the limited issue of whether the fire service user fee should be approved. On April 24, 2013 and April 30, 2013, WaterPro Inc. filed proof of notice to its customers who will be charged the fire service user fee. On May 6, 2013, the Division of Public Utilities filed a recommendation to approve the fee.

Notice is given that a hearing in the above-entitled matter will be conducted by the Administrative Law Judge of the Public Service Commission on **Monday, May 20, 2013, beginning at 9:00 a.m. (MDT). The hearing will be held in the Fourth Floor Hearing Room 451, Heber M. Wells Building**, 160 East 300 South, Salt Lake City, Utah. This hearing is being scheduled to address the limited issue of whether the fire service user fee requested by WaterPro Inc. in this docket should be approved. All parties must have their witnesses in attendance and prepared to testify. Any interested party may file comments in this docket on or before May 17, 2013.
