Please note, as set forth in the Scheduling Order, issued July 18, 2013, Cedar Ridge was required to file its proof of "notice to its customers of the interim rate increase hearing" no later than July 22, 2013. (Please see page 2 of the Scheduling Order). As we did not explicitly discuss this issue at the scheduling conference, and because today is July 23, 2013, the Commission is sending this email for your immediate attention. As you are aware, filings must be made with the Commission with the proper number of copies, pursuant to Utah statutes and rules.

Please also note, as set forth in the Scheduling Order referenced above, "[n]o later than Company's August 2013 and September 2013 billing cycles, Company is instructed to provide notice to its customers of the general rate increase hearing...."

Please be advised that reminders of this sort do not typically come from the Commission, and you should not expect them in the future. However, given these deadlines were not explicitly discussed during the scheduling conference, the Commission is sending this reminder as a onetime courtesy.
