Unfortunately a telephone meeting will not work. This is the opportunity for you to show your evidence to Ray Bowden and Mr. Smith which form the basis for your allegation that you were overbilled in the month of August. This will be their opportunity to show to you what evidence they have as well. This is the same process that would take process in a hearing many months from now and the Judge would be looking at the evidence providing by both parties. The Division wants us to show evidence and to see if we can resolve this between ourselves. A telephone call makes it impossible to show evidence or to negotiate.
