
Commission Representative:

My name is Guy Rawson and serve as the President for the Hidden Creek HOA. I am submitting this signed Petition so that I can be granted intervener status for the pending rate increase case for Community Water Company—Docket No. 15-098-01, and the previous related Docket 14-098-01 also for Community Water Company. Our HOA represents a significant portion of the impacted customer base in the Service District of Community Water Company. Based upon a very preliminary review, the proposed rate increase represents a significant increase to the homeowners in the HOA as well as all other customers in the Service District, and as such warrants a significant effort to better understand the full impacts of this proposal before the Public Service Commission.

At this time, the relief sought by intervening is mainly to obtain access to the documents supporting the rate increase contained in the Dockets, to review these documents thoroughly and to conduct an independent analysis of the impacts to the our HOA.
