ISSUED: June 11, 2014

On June 6, 2014, the Commission issued an order suspending Hi-Country Estates Homeowners Association's (Company) proposed tariff, and setting the matter for hearing.<sup>1</sup> The Company thereafter filed a response requesting the Commission waive the scheduled hearing and issue an order detailing the changes needed in the Company's proposed tariff.<sup>2</sup> Given the extent of the comments filed by the Division of Public Utilities and the additional concerns noted by the Commission in its June 6, 2014, order suspending the Company's proposed tariff, the Company's request to waive the hearing scheduled in this matter is denied.

NOTICE OF HEARING

A hearing in this matter is scheduled for **Friday, June 27, 2014, beginning at 9:00 a.m., Fourth Floor Hearing Room 451, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** The hearing will be conducted by the Administrative Law Judge for the Public Service Commission. Parties should come prepared to provide testimony, clarification, and/or additional information requested in the attached order on whether Hi-Country's proposed tariff, filed May 15, 2014, in this docket, should be approved by the Commission.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the Commission within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
