For some time we have been encouraging you to convert your deeded irrigation rights to certificated rights. Most have taken this step. You have not.

Because DVWW has no control over the transfer of deeded rights and no way to follow up on keeping the rights current, there is a chance that the right can be lost or jeopardized. The certificated rights are kept current by the Water Company and we control their transfer. For your own protection we strongly encourage you to deed your right back to the Water Company and we will issue you a certificate for the same right.

If you would like to talk this over with the people at the Division of Water Rights you can call them in Cedar City at 586-4231. They probably won't encourage you to take this step, but they will confirm that the Certificated Rights are a simpler, safer and more typical way for you to hold your right.

It's simple for you to make the conversion. Let us know you want to do it and we'll prepare the deed for you to sign, and upon receiving your deed we will issue you a certificate from Dammeron Valley Water Works. We'll then maintain your right with the Division of Water Rights and keep a record of all transfers. For you nothing else will change. You'll still have the same perpetual use of the water at the irrigation rate and the same right to transfer the right that you had with the deeded right.

Dear Share Owners.

We have been encouraged by the Division of Water Rights to offer Certificates of Irrigation Rights rather than deeding the Water Rights. All future irrigation shares will be issued by Certificates which will give the holder the same rights to cheap irrigation water as before, but save him the paperwork of keeping his rights current. The Certificates will also facilitate the transfer of the right upon sale of the lot or the water right.

Those of you who own your rights by way of a quitclaim deed issued by The Dammeron Corp, parent company of Dammeron Valley Water Works, are encouraged to deed the rights back to DVWW, who will then issue you a certificate. This will save you responding to the Division of Water Rights in the future when they question wheather you are beneficially using your water. Failure to respond to them could cause a loss of the water right.

Enclosed is a Quit Claim Deed for you to fill out, sign and get notorized to effect the legal transfer of the water right back to DVWW. Please fill in the names of the owners of the right in the first blank of the deed, and the number of acre feet you own in the second blank. The third blank is for the Water Users Claim number which you can find on the original deed. If you can't find it I'll fill it in when I get the deed back. All owners should then sign the deed and have their signitures notarized. Make sure the signitures correspond to the original deed. Mail the signed and notarized deed back to me; I'll arrange to have the deeds recorded and the records of the Division of Water Rights updated.

You will then be mailed a Certificate verifying your right to the same amount of water you deed back to DVWW.

Dear Share Owners;

Last spring you were notified that Irrigation Shares would be issued by Certificate rather than Quit Claim Deed. I encouraged you to deed your water rights back to Dammeron Valley Water Works, at which time we would issue you a new Certificate. Many of you have done this and have your new Certificates. Those of you who haven't are encouraged to do so at this time.

The procedure is now very simple. Call or drop in on Carol in my office any weekday between 10 am and Noon and she will prepare your deed and notarize your signature. She will then prepare your Certificate and give it to you. The Certificates will facilitate the transfer of your water rights upon the sale of the lot or the water right. It will also save you responding to the Division of Water Rights in the future when they question whether you are beneficially using your water. Failure to respond to them could cause a loss of the water right.

If you have any questions about this issue please get in touch with us. You are not giving up anything. In fact your right will be more secure and less apt to suffer from outside regulation once you have converted your deeded right to a Certificate. Dammeron Valley Water Works will not be able to protect or assist in transfer of rights in the future if they are not held by a Certificate that we have issued.
