**Subject: Petition to Intervene in Adjudicative Proceeding Docket No. 16-098-01, 15-098-01, No. 14-098-01**

Commission Representative:

My name is Francis Amendola. I am submitting this signed Petition so that I can be granted intervener status for Docket No. 16-098-01 for Community Water Company (CWC), and the previous related Dockets 15-098-01 and 14-098-01 also for Community Water Company. I received a copy of the Petition for an Order to Show Cause via email from Ms. Patricia Schmid on February 19, 2016, and reviewed the Show Cause Order dated February 22, 2016 in Docket 16-098-01 on the PSC website. Mr. Terry Lange, President of the Red Pine Homeowners Association (HOA) and Mr. Guy Rawson of the Hidden Creek HOA have retained my services to assist the HOAs in evaluating the impacts of the rate case to their HOAs. Red Pine HOA and Hidden Creek HOA represent a significant portion of the impacted customer base in the Service District of Community Water Company. I managed Community Water Company for several years and have a solid understanding of the system. I also supported their efforts in evaluating the impacts of previous cases covered under Dockets 15-098-01 and 14-098-01, and met with the Division of Public Utilities during that rate case to provide input. Any newly proposed rate could represent a significant impact to the homeowners in the Red Pine and Hidden Creek HOAs as well as all other customers in the Service District of CWC.

At this time, the relief sought by intervening is mainly to obtain access to the documents supporting the rate increase contained in the Dockets, to review these documents thoroughly and to conduct an independent analysis of the impacts to the Red Pine and Hidden Creek HOAs. After conducting this analysis, further efforts may be warranted including working with the Division as well as participation in the formal hearing proceedings. I will provide the background analysis so that the HOAs can decide how best to proceed. Mr. Terry Lange is available to confirm my support role. 
