Discovery turn-around times are 21 calendar days if served on or before March 31, 2017; 14 calendar days if served between March 31, 2017 and June 30, 2017; and according to best efforts if served between June 30, 2017 and July 5, 2017. Where feasible, parties shall serve discovery requests and responses on applicable parties by electronic mail.

A party that objects to a discovery request shall serve the objection on the requesting party within five business days after receiving the request.

WaterPro Inc. shall provide this Scheduling Order and Notice of Hearings to customers as part of the first billing that occurs in WaterPro Inc.'s regular billing cycle following the date of this order.

NOTICES OF HEARING

The following provisions apply to both hearings noticed under this heading.

Individuals wishing to participate in the hearing by telephone should contact the PSC two days in advance by calling (801) 530-6716 or (toll free) 1-866-PSC-UTAH (1-866-722-8824) to receive a bridge number and participant passcode. Participants attending by telephone should then call the bridge number five minutes before the hearing, entering the passcode followed by the # sign to ensure participation.

I. GENERAL RATE INCREASE HEARING

II. PUBLIC WITNESS HEARING

A public witness hearing in this docket will be conducted by the Administrative Law Judge for the PSC on **Monday, August 7, 2017, beginning at 12:00 P.M.** The hearing will be held in the **Fourth Floor Hearing Room 451, Heber M. Wells Bldg., 160 East 300 South, Salt Lake City, Utah.**

The PSC may limit presentation of testimony or comments that are unduly repetitious. Individuals wishing to provide public witness testimony or comment must appear at this hearing at the appointed time. Individuals may offer comments or sworn testimony, but should note that individuals presenting sworn testimony are subject to cross-examination. Any individual who wishes to present a statement of position to the PSC, but who is unable to do so during the Public Witness hearing, may file a written statement of position with the PSC as follows:
