Mountain Sewer Corporation ("Mountain Sewer" or "Company"), hereby submits its proposed revised rates to the Utah Public Service Commission ("Commission"), pursuant to the Commission's Report and Order issued on October 30, 2012 in Docket 11-097-03 (the "Order").

1. Background

- a. Mountain Sewer filed a general rate case on April 6, 2012 in Docket 11-097-03. That Docket was combined with two other then-concurrent Mountain Sewer Dockets (11-097-01 and 11-097-02).
- b. On October 30, 2012, the Commission issued the Order, which, among other things, approved new rates and fees for Mountain Sewer, effective as of the date of the Order.
- c. Mountain Sewer filed a revised tariff reflecting the Commission's Order on November 9, 2012 in Docket 12-097-T01.

- d. The new rates approved in the Order included the recovery of rate case legal expenses over a period of five years. (Order at 13-14.)
- e. The Order directed Mountain Sewer to file new rates reflecting the completed recovery of amortized rate case legal expenses no later than June 1, 2017. (Order at 14.)

2. Current Rates

- a. Mountain Sewer's current rates, as approved by the Order, are as follows: \$84.25 per month for active customers and \$25.25 per month for standby customers. (Order at 12.)
- b. The current rates include annual amortization of rate cases expenses of \$26,172.88, of which 10 percent (\$2,617.29) is allocated to system expenses and 90 percent (\$23,555.59) is allocated to usage expenses. (See DPU Exhibit 3.2, filed on August 23, 2012.)

3. Revised Rates

- a. By removing the annual amortization of rate case expenses in the amount of \$26,172.88 from the calculation of the rates and making no other changes, the resulting revised rates are as follows: \$68.00 per month for active customers and \$24.00 per month for standby customers.
- b. Mountain Sewer has consulted with the Division of Public Utilities in calculating the new rates and the rates above are consistent with the calculations made by the Division.
- c. In the current tariff, the rates are set forth on Sheet No. 4. Mountain Sewer has prepared replacement Sheet No. 4, filed concurrently with this document, reflecting the new rates set forth in the previous paragraph.

4. Conclusion

a. Mountain Sewer respectfully requests that the Commission accept and approve revised Tariff Sheet No. 4, with the new decreased rates becoming effective on October 30, 2017.
