My name is Leanne Miller. I am submitting this signed Petition for myself so that I can be granted intervener status for the pending rate increase case for Community Water Company—Docket No. 17-098-01 and the previous related Docket No. 15-098-01 and Docket No. 14-098-01 (deemed incomplete). I am the President of the Park West Condominiums dba Hidden Creek at the Canyons Homeowners Association (Hidden Creek HOA). We have also retained the services of Mr. Francis Amendola to assist the HOA in evaluating the impacts of this new rate case to our HOA. Mr. Amendola will file for intervener status. I am seeking intervener status so as to fulfill and honor my fiduciary responsibility as Board President to all members of the Hidden Creek HOA.


Hidden Creek HOA represents a significant portion of the impacted customer base in the Service District of Community Water Company. Hidden Creek consists of 130 shared meter customers with over 8 irrigated acres. It is crucial to have this proposal properly understood so as to be fair and equitable not only to the 130 HOA customers but as it relates to the customer base as a whole. Any new rate will have a significant impact to the homeowners in the Hidden Creek HOA as well as all other customers in the Service District, and as such warrants a significant effort to better understand the full impacts of this proposal before the Public Service Commission.

At this time, the relief sought by intervening is to obtain access to the documents supporting the rate increase contained in the Dockets, to review these documents thoroughly and to conduct an independent analysis of the impacts to the Hidden Creek HOA. After conducting this analysis, further efforts may be warranted including participation in the rate application proceedings.
