Commission Representative:

My name is E. Scott Savage. I am submitting this signed Petition for myself so that I can be granted intervener status for the pending rate increase case for Community Water Company - Docket No. 17-098-01. Previously, I was granted intervenor status in the related Dockets 16-098-01, 15-098-01 and 14-098-01 which were prior rate cases for Community Water Company. I am the President of the Plat B & D Homeowners Association (HOA) and I am seeking intervener status so as to fulfill and honor my fiduciary responsibility to all members of the Plat B & D HOA.

Plat B & D HOA represents a significant portion of the impacted customer base in the Service District of Community Water Company. The thirty homeowners of Plat B&D together constitute one of the largest users of water supplied by Community Water Company. Based upon a very preliminary review, the proposed rate increases represent significant increases not only to the homeowners in the Plat B & D HOA but as well as all other customers in the Service District,

and as such warrants a significant effort to better understand the full impacts of this proposal before the Public Service Commission.


At this time, the relief sought by intervening is to obtain access to the documents supporting the rate increase contained in the Dockets, to review these documents thoroughly and to conduct an independent analysis of the impacts to the Plat B & D HOA. After conducting this analysis, further efforts may be warranted including participating in the formal hearing proceedings.

In addition to petitioning for intervener status, I am also requesting access to the past two Annual Report and Gross Revenue Reports. These reports are crucial in understanding the financial condition of Community Water Company and how it relates to the proposed rate increase.

I have read Rule R746-100-16 governing use of confidential information and have completed and signed the Confidential Information Certificate for 15-098-01 and 14-098-01. These signed certificates are included in the mailing of this signed Petition to the Public Service Commission of Utah.
