NOTICE OF FILING

On July 27, 2017, Tanya and Nick Olsen filed a formal complaint against South Duchesne Culinary Water Inc., a public utility. The Olsens allege that, despite timely bringing their account current after receiving a notice of delinquency, South Duchesne Culinary Water Inc. has terminated service and refuses to reconnect the utility service.

NOTICE OF COMMENT PERIOD

South Duchesne Culinary Water Inc. may submit a response to The Olsen's complaint no later than **Monday, August 28, 2017**. The Olsens may file a reply no later than **Tuesday, September 12, 2017**.

INTERIM ORDER TO RESTORE SERVICE

On the basis of the unique documentary evidence provided by the Olsens in their complaint, the Public Service Commission of Utah concludes that the Olsens are entitled to water utility service during the pendency of this action and, therefore, orders Duchesne Culinary Water Inc. to restore water utility service no later than close of business on July 28, 2017. Utah Administrative Code R746-200-6.
