Having reviewed South Duchesne Culinary Water, Inc.'s ("SDCW") Motion to Dismiss and the attendant briefing, the Public Service Commission ("PSC") finds issues of fact exist as to whether SDCW has failed to comply with one or more applicable customer service rules as outlined in the Utah Administrative Code. Complainant Tanya Olsen's Formal Complaint is, therefore, not moot. SDWC's Motion to Dismiss is denied.

**NOTICE OF HEARING**

The PSC will conduct a hearing to consider the Formal Complaint on **Monday, December 11, 2017, beginning at 9:00 a.m. (MST)**. The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah**. All parties must have their witnesses in attendance and prepared to testify.
