	<u>ORDER GRANTING EXTENSION OF TIME</u>

ISSUED: September 28, 2018

On February 13, 2018, the Public Service Commission (“PSC”) issued its Consolidated Order in the above-referenced dockets. Ordering paragraph six states: “The [Division of Public Utilities (“DPU”)] shall conduct a review in six months, beginning on or before August 13, 2018, to ensure [South Duchesne Culinary Water, Inc. (“SDCW”)] has adopted billing procedures, including the assessment of late fees, that are consistent with the Rules and its tariff. The DPU shall file a report with the PSC on or before October 1, 2018, apprising the PSC of the status of SDCW’s compliance.”<sup>1</sup> On September 27, 2018, the DPU filed a memorandum requesting a 30-day extension from the PSC (“Request”) “in order to collect more documentation and to further review and analyze the billing process of [SDCW].”<sup>2</sup> Good cause appearing, therefore, the Request is granted. Accordingly, the DPU shall have until **Wednesday, October 31, 2018** to file the report previously ordered by the PSC.
