Formal Complaint of Shane Houskeeper  
against South Duchesne Culinary Water, Inc.

ISSUED: April 25, 2018

On April 9, 2018, Shane Houskeeper filed a document styled Petition for Redetermination. The document raises arguments against South Duchesne Culinary Water, Inc.’s (“SDCW”) Petition for Redetermination, upon which the Public Service Commission (“PSC”) has already ruled, and contains new allegations concerning SDCW’s failure to comply with the PSC’s prior orders in this docket. To the extent Mr. Houskeeper wished to respond to SDCW’s Petition for Redetermination, the new document is untimely. However, Mr. Houskeeper’s allegations concerning SDCW’s failure to comply with the PSC’s orders warrant further review.

On April 18, 2018, SDCW filed a response to Mr. Houskeeper’s filing, indicating it had made an error in calculating the amount owed to Mr. Houskeeper, and representing it had remediated the problem. Also on April 18, 2018, the PSC issued an Action Request to the Division of Public Utilities (“DPU”), requesting it review Mr. Houskeeper’s April 9 filing and indicate whether the DPU has a recommendation.

If Mr. Houskeeper or SDCW wishes to make further comment on the allegations in Mr. Houskeeper’s April 9 filing, such comments must be filed on or before **Thursday, May 10, 2018**. Having reviewed any such comments and the DPU’s response to the Action Request, the PSC will schedule additional proceedings as appropriate. If SDCW is found to have committed additional violations, beyond those previously found to have occurred in this docket, it will be subject to the full penalty otherwise suspended in the PSC’s Consolidated Order on Petition for
