DISCOVERY

NOTICE OF HEARING

The PSC will conduct a hearing in this docket on **Tuesday, December 15, 2020, beginning at 10:00 a.m.** The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** All parties must have their witnesses in attendance and prepared to testify.

As such, the PSC may limit the length of individuals' remarks.
