ISSUED: November 16, 2020

On June 8, 2020, the Public Service Commission (PSC) issued a Scheduling Order, Notice of Hearing, and Notice of Public Witness Hearing (“Scheduling Order”) in this docket. On November 12, 2020, the Division of Public Utilities (DPU) filed an Unopposed Motion to Suspend Testimony Dates While Retaining Hearing Dates as Scheduled (“Motion”). DPU represents it has been involved in settlement discussions with Pineview West Water Company (“Pineview”) and asks the remaining deadlines for filing testimony set in the Scheduling Order be suspended. DPU requests that the dates for the hearings remain unchanged. DPU states Pineview has authorized it to represent that Pineview supports the Motion. There are no other intervenors in the docket.

Good cause appearing, the Motion is granted and the remaining deadlines for filing testimony are suspended. The evidentiary hearing is scheduled for Tuesday, December 15, 2020, beginning at 10:00 a.m., and the Public Witness Hearing is scheduled for Tuesday, December 15, 2020, beginning at 5:00 p.m.
