Public Witness Hearing:

All parties Rebuttal Testimony, currently due June 19, 2020; and
All parties Surrebuttal Testimony, currently due July 1, 2020.

The Division requests that the Commission retain the hearing date and the public witness hearing date of July 29, 2020 as previously scheduled.

Due to the approaching non-Applicant direct testimony filing date of June 12, 2020, the Division requests that the Commission expedite its consideration of this Motion.
