On March 20, 2020, the Public Service Commission (PSC) issued a Scheduling Order, Notice of Hearing, and Notice of Public Witness Hearing (“Scheduling Order”) in this docket. On June 9, 2020, the Division of Public Utilities (DPU) filed an Unopposed Motion to Suspend the Procedural Schedule Except for the Hearing Dates and Request for Expedited Consideration (“Motion”). The DPU represents it has been involved in settlement discussions with WaterPro, Inc. (“WaterPro”) and asks that the remaining deadlines for filing testimony set in the Scheduling Order be vacated. The DPU asks that the dates for the hearings remain unchanged. The DPU states WaterPro has authorized it to represent that WaterPro supports the Motion.
