Dear Mr. Widerburg,

The Division of Public Utilities (Division) and WaterPro Inc. (WaterPro) submit the following documents for filing. Attachment 1 is an executed Corrected Settlement Stipulation (Corrected Stipulation). Attachment 2 consists of WaterPro's tariff in both redline and clean form incorporating the provisions of the Corrected Stipulation. These documents are filed consistent with statements made during the July 29, 2020 hearing in this docket.

Corrected Stipulation

The Corrected Stipulation appended as Attachment 1 reflects changes to paragraph 13. I failed to correctly edit paragraph 13 in the Settlement Stipulation (Original Stipulation) filed on June 30, 2020. The Original Stipulation stated:

13. Updated Tariff Sheets. The Parties agree that WaterPro has reviewed and revised its tariff to reflect the rate increase set forth above and the Parties seek approval of those updated tariff sheets provided here as Attachment 1 to this Stipulation. Once approved, the revised tariff sheets will be available along with the rest of the Company's tariff for public viewing at its offices in Draper, Utah.

The Original Stipulation should have said, in essence, that WaterPro will revise, file, and request approval of revised tariff sheets instead of saying that the tariff sheets were attached. The corrections are presented below in redline form and are incorporated in clean form into the Corrected Stipulation:
