Unopposed Motion to Suspend
Testimony Dates while Retaining
Virtual Hearing Dates as
Scheduled

Pursuant to R746-1-301 of the Public Service Commission of Utah's (Commission) rules, the Division of Public Utilities (Division) files this "Unopposed Motion to Suspend Testimony Dates while Retaining Virtual Hearing Dates as Scheduled" (Motion). There are no intervenors in this docket. The Division is authorized to represent that Bridgerland Water Company (Bridgerland) supports this Motion.

The Division is authorized to represent that Bridgerland has provided the following customer notices. In a letter dated February 10, 2021, Bridgerland provided its customers notice of the impending rate case, included the docket number and link to the Commission's website, and encouraged the customers to check the website frequently. On January 7, 2022, Bridgerland emailed those customers with email addresses notice of the rate case hearing. On January 8,

2022, Bridgerland mailed notice of the rate case hearing to customers without email addresses. The January 2022 notices included information that there was a proposed settlement agreement, included the link to the docket, and again referenced the time and date of the hearings.

On January 14, 2022, the Commission issued notice that the in person hearings scheduled for February 9, 2022 would be held virtually.

The Division and Bridgerland (the Parties) are engaging in fruitful settlement discussions, and they anticipate filing an executed Settlement Agreement soon. Accordingly, the Parties request that the schedule be suspended, except for the virtual hearings scheduled for February 9, 2022.

The Division will ask Bridgerland to send its customers notice that the hearings have been converted to virtual hearings, that a settlement agreement has been reached if such agreement is achieved, and, if this motion is granted, that the schedule has been suspended except for the virtual hearings.

The Division requests that the Commission approve this Motion to suspend the schedule, except for the virtual hearing dates.
