ORDER GRANTING MOTION TO VACATE
SCHEDULING ORDER, AMENDED
SCHEDULING ORDER, NOTICE OF
HEARING ON STIPULATION, AND
NOTICE OF PUBLIC WITNESS HEARING

ISSUED: July 22, 2022

On April 11, 2022, the Public Service Commission (PSC) issued a Scheduling Order, Notice of Hearing, and Notice of Public Witness Hearing (“Scheduling Order”) in this docket. On July 20, 2022, the Division of Public Utilities (DPU) filed a Settlement Stipulation along with an Unopposed Motion to Approve Settlement Stipulation, to Vacate the Scheduling Order Except for the Hearing Date, and to Hold Hearings as Scheduled (“Motion to Vacate Scheduling Order”).¹ DPU asks the PSC to vacate the remaining deadlines for filing testimony set in the Scheduling Order. DPU requests the PSC hold the hearing and public witness hearing as scheduled for August 4, 2022 to consider the Settlement Stipulation. DPU states WaterPro has authorized it to represent that WaterPro supports the Motion to Vacate Scheduling Order.

Good cause appearing, we grant the Motion to Vacate Scheduling Order as proposed. The amended schedule in this docket shall be as follows:

¹ The Motion to Approve Settlement Stipulation is not granted at this time. The PSC will issue its decision on that issue following the hearing.
