Pursuant to R746-1-301 of the Public Service Commission of Utah’s (“Commission”) rules, the Division of Public Utilities (“Division”) files this “Unopposed Motion to Vacate the Scheduling Order Except for the Hearing and Public Witness Hearing Date and for Expedited Treatment” (“Motion”). The Division is authorized to represent that Mountain Sewer Corporation (“Mountain Sewer”) supports this Motion. There are no intervenors in this docket.

The Division and Mountain Sewer (“the Parties”) are engaging in fruitful settlement discussions and anticipate filing an executed settlement stipulation soon. Accordingly, the Parties request that the schedule be vacated, except for the hearings scheduled for August 23, 2023. The Division also seeks expedited treatment of this Motion because rebuttal testimony

of all parties is due this Thursday, August 3, 2023.

The Division will ask Mountain Sewer to send its customers notice that a settlement agreement has been reached if such an agreement is achieved, and, if this motion is granted, to provide notice of the scheduled hearings.

The Division requests that the Commission approve this Motion to vacate the Scheduling Order, while retaining the scheduled hearing and public witness hearing date, and for expedited treatment of this Motion.
