ORDER GRANTING MOTION TO VACATE
SCHEDULING ORDER, AMENDED
SCHEDULING ORDER, NOTICE OF
HEARING, AND NOTICE OF PUBLIC
WITNESS HEARING

ISSUED: August 3, 2023

On February 9, 2023, the Public Service Commission (PSC) issued a Scheduling Order, Notice of Hearing on Interim Rates, Notice of Hearing, and Notice of Public Witness Hearing (“Scheduling Order”) in this docket. On August 2, 2023, the Division of Public Utilities (DPU) filed an Unopposed Motion to Vacate the Scheduling Order Except for the Hearing and Public Witness Hearing Date and for Expedited Treatment (“Motion to Vacate Scheduling Order”). DPU states it has been engaging in settlement discussions with Lakeview Water Corporation (“Lakeview”) and the parties anticipate filing a settlement stipulation soon. DPU asks the PSC to vacate the remaining deadlines for filing testimony set in the Scheduling Order. DPU requests the PSC hold the hearing and public witness hearing as scheduled for August 24, 2023. DPU states it is authorized to represent that Lakeview supports the Motion to Vacate Scheduling Order.

Good cause appearing, we grant the Motion to Vacate Scheduling Order as proposed. The amended schedule in this docket shall be as follows:

Wells Building, 160 East 300 South, Salt Lake City, Utah.** The Public Witness hearing will continue until all present individuals have had a reasonable opportunity to address the PSC. Individuals planning to address the PSC at the Public Witness hearing must be present by 6:00 p.m.
