APPLICATION OF LAKEVIEW WATER CORPORATION FOR GENERAL RATE INCREASE	Docket No. 22-540-01 Unopposed Motion to Approve Settlement Stipulation and Hold Hearings as Scheduled

Pursuant to R746-1-301 of the Public Service Commission of Utah’s (“Commission”) rules, the Division of Public Utilities (“Division”) files this Unopposed Motion to Approve Settlement Stipulation and Hold Hearings as Scheduled (“Motion”). The Division is authorized to represent that Lakeview Water Corporation (“Lakeview”) supports this Motion. There are no intervenors in this docket. The Division and Lakeview (“the Parties”) have engaged in fruitful settlement discussions that have resulted in the execution of the Settlement Stipulation filed contemporaneously with this Motion.

On August 2, 2023, the Division filed an Unopposed Motion to Vacate the Scheduling Order Except for the Hearing and Public Witness Hearing Dates and for Expedited Treatment requesting the Commission vacate the remaining deadlines for filing testimony and retain the August 24, 2023, date for the hearing and public witness hearing. On August 3, 2023, the

Commission issued its Order Granting Motion to Vacate Scheduling Order, Amended Scheduling Order, Notice of Hearing, and Notice of Public Witness Hearing (“Order”). The Order set forth an amended schedule for the docket that vacated the remaining testimony deadlines and kept the hearing and public witness hearing as scheduled for August 24, 2023.

The Division requests that the Commission approve this Motion and hold both the hearing and public witness hearing as scheduled on August 24, 2023, to consider the Settlement Stipulation. The Parties will provide witnesses at the hearing supporting approval of the Settlement Stipulation.

On July 28, 2023, Lakeview provided to its customers notice of the proposed Settlement Stipulation and a link to the Commission’s website where the Settlement Stipulation and notice of the scheduled hearings can be found.
