RE: Application of Lakeview Water Corp. for General Rate Increase – Docket No. 22-540-01

Dear Mr. Widerburg:

The Division of Public Utilities (“Division”) has enclosed for filing with the Public Service Commission of Utah (“Commission”) the Second Corrected Attachment A and Second Corrected Attachment B, the redline and clean versions of Lakeview Water’s proposed tariff. The Second Corrected Attachments replace outdated tariff language but retain the rates and fees schedule included in the previously filed Corrected Attachments and add a turn-on and turn-off fee.

On August 14, 2023, the Division filed with the Commission the Settlement Stipulation with Attachment A and Attachment B, the redline and clean versions of Lakeview Water’s proposed tariff. The Commission issued an Action Request to the Division on August 16, 2023, to clarify the inconsistency between the rate structure in the filed Settlement Stipulation and the rates and fees schedule in Attachment A and Attachment B. On August 17, the Division submitted its Action Request Response that included Corrected Attachment A and Corrected Attachment B. The filed Corrected Attachments reflect the agreed upon rate structure as presented correctly in the Settlement Stipulation itself.

After submitting the Action Request Response with the Corrected Attachments, the Division realized that much of the tariff language was based on outdated templates. After discussing with

Lakeview Water, the Division updated the redline and clean versions of the tariff to be consistent with current Division recommendations. The updated tariff retains the rates and fees schedule present in the Corrected Attachments and adds a turn-on and turn-off fee to that schedule. Lakeview Water has reviewed and agreed to the revised tariff as reflected in the enclosed Second Corrected Attachment A and Second Corrected Attachment B.
