Joint Motion to Substitute Third Corrected Attachments for the Settlement Stipulation Attachments

Pursuant to R746-1-301 of the Public Service Commission of Utah's ("Commission") rules, the Division of Public Utilities ("Division") and Lakeview Water Corporation ("Lakeview Water") (collectively the "Parties") file this Joint Motion to Substitute the Third Corrected Attachments for the Settlement Stipulation Attachments. Consistent with the discussion during today's hearing on the Settlement Stipulation, the Parties submit for filing

Third Corrected Attachment A, the revised redline version of the proposed tariff, and Third Corrected Attachment B, the revised clean version of the proposed tariff, to replace the attachments that were originally filed with the Settlement Stipulation.

On August 14, 2023, the Division filed the signed Settlement Stipulation, including the proposed tariff as Attachment A, the redline version, and Attachment B, the clean version. On August 16, 2023, the Commission issued an Action Request to the Division to clarify the inconsistency between the rate structure in the Settlement Stipulation and the rates and fees schedule in Attachment A and Attachment B. The Division filed its Action Request Response on August 17, 2023, and included Corrected Attachment A and Corrected Attachment B, which corrected the rates and fees in the proposed tariff to correspond to the rate structure that was correctly presented in the Settlement Stipulation itself.

On August 22, 2023, the Division filed the Second Corrected Attachments to replace outdated tariff language in the Corrected Attachments that were filed on August 17, 2023, and to be consistent with current Division recommendations. The Second Corrected Attachments retained the rates and fees schedule in the Settlement Stipulation and added a turn-on and turn-off fee. The Second Corrected Attachment A, the redline version of the proposed tariff, struck through the old tariff language based on an outdated template and replaced the tariff with new language. The Second Corrected Attachment B is a clean version of the same.

During today's hearing, the Commission noted certain inconsistencies between the previously filed Second Corrected Attachment A and Second Corrected Attachment B. To resolve the inconsistencies between the redline and clean versions of the revised tariff, the Parties have enclosed for filing the Third Corrected Attachment A and Third Corrected Attachment B, which represent the final version of Lakeview Water's Tariff No. 3. The Third

Corrected Attachment A, the redline version, and Third Corrected Attachment B, the clean version, incorporate the changes necessary to rectify the inconsistencies identified by the Commission and reflect the changes the Parties agreed to at today's hearing.

The Parties move to substitute the enclosed Third Corrected Attachment A and Third Corrected Attachment B for the Attachment A and Attachment B referenced in paragraph 19 of the Settlement Stipulation.
