Formal Complaint of Steven Watterson against Bridgerland Water Company

NOTICE OF VIRTUAL STATUS UPDATE CONFERENCE

ISSUED: May 4, 2023

On March 17, 2023, complainant Steven Watterson ("Mr. Watterson") filed a formal complaint against Bridgerland Water Company ("BWC") relating to "frozen pipes" at his property ("Complaint"). Also on March 17, 2023, the Public Service Commission (PSC) issued an Action request to the Division of Public Utilities (DPU) seeking comments based on its review of the Complaint ("Comments"). The DPU filed its Comments on April 3, 2023.

On March 20, 2023, the PSC issued a Notice of Filing and Comment Period, advising of the filing of the Complaint, providing BWC until April 17, 2023, to submit a written response to the Complaint, and providing Mr. Watterson until May 2, 2023, to submit a written reply. BWC responded on April 14, 2023 ("Response"), and Mr. Watterson did not file a written reply.

Having reviewed the Complaint, BWC's Response, and DPU's Comments, it appears that Mr. Watterson and BWC may have reached an agreement concerning the Complaint or that it has otherwise been resolved. Utah law encourages settlement and resolution of disputes by the parties, and while the written submissions appear to

address and conceptually agree on most issues and remedies presented and offered, it is unclear whether Mr. Watterson's Complaint has been resolved.
