We appreciate response and the time the Commission spent on our behalf. I guess we will continue to wait for the water to be usable once again. We hope to hear an update from Bridgerland Water soon on when the water is back on and we have been credited February, March, April and perhaps May.

I wanted to note for the file that in the Discussion portion of the response it explains that running water is widely accepted, for example by the Red Cross. The contractor who installed our septic system, as required in Bridgerland, informed us a trickle of water "drip from faucets" would overwhelm and ruin the system causing an excess of gray water or even a frozen pile in the septic tank. Running water outside was also not a possibility as the hose bibs and faucets were buried under many feet of snow.
