On August 24, 2023, the Public Service Commission (PSC) issued a Notice of Virtual Hearing and to Parties to be Prepared to Address Specific Issues at Hearing ("Notice"). That Notice set a virtual hearing for September 14, 2023 ("Hearing").

On August 25, 2023, Bridgerland Water Company ("BWC") requested to reschedule the Hearing because of one of the witnesses it needs at the Hearing is unavailable during the currently scheduled date and time. In response to BWC's request, complainants Ronda and Martell Menlove ("Complainants") expressed a general concern about delay, but they also expressed their understanding of the importance of having BWC's witness attend the Hearing.

Balancing the interests at issue on BWC's request, good cause exists to reschedule the Hearing. The PSC grants BWC's request and reminds the parties that the factual issues outlined in the Notice will be addressed at this rescheduled hearing.

The PSC, therefore, gives notice of a rescheduled virtual hearing in this docket on **Wednesday, September 27, 2023, beginning at 10:30 a.m.** The hearing will be conducted via Webex at the following link: <https://utah-psc.webex.com/utah-psc/j.php?MTID=ma111810c56c376112ad1955e8de3fbac>. All parties must have their witnesses in attendance and prepared to testify. The PSC requests that attorneys and

witnesses make themselves available by both video and audio during the portions of the hearing in which they will be actively participating. Participants are free to deactivate video, and should always mute audio, when not actively participating.
