On April 12, 2024, the Public Service Commission (PSC) issued a Scheduling Order and Notice of Hearing (“Scheduling Order”) in this docket. Applicant Highlands Water Company, Inc. and intervenors Mountain Green Mutual Water Company and Village at Trappers Loop LLC subsequently filed a Stipulated Motion to Suspend Deadlines (“Motion”) in the Scheduling Order. The Motion was granted on August 16, 2024, and an additional scheduling conference was set.

At the scheduling conference the PSC held on September 11, 2024, the parties in attendance stipulated to the following schedule, which the PSC approves and adopts:

DISCOVERY

Wells Building, 160 East 300 South, Salt Lake City, Utah.** All parties must have their witnesses in attendance and prepared to testify. **Parties should also reserve Tuesday, January 28, 2025, from 1:00 p.m. until 5:00 p.m., in the event the hearing lasts more than one day.** Any person desiring to attend this event must show government-issued photo identification to be admitted past the building security station.
