WANSHIP WATER COMPANY, LLC'S REQUEST FOR A RATE INCREASE	Docket No. 23-067-01 Unopposed Motion to Vacate the Scheduling Order and Set New Date for Hearing and Public Witness Hearing and for Expedited Treatment

Pursuant to R746-1 of the Public Service Commission of Utah's ("Commission") rules, the Division of Public Utilities ("Division") files this Unopposed Motion to Vacate the Scheduling Order and Set New Date for Hearing and Public Witness Hearing, and for Expedited Treatment ("Motion"). The Division is authorized to represent that Wanship Water Company, LLC ("Wanship") supports this Motion. There are no intervenors in this docket.

The Division and Wanship ("the Parties") are engaging in fruitful settlement discussions and anticipate filing an executed settlement stipulation soon. Accordingly, the Parties request that the schedule be vacated and that the Commission set November 1, 2023, as the new date for the in-person hearing and virtual public witness hearing. The Division also seeks expedited treatment of this Motion because rebuttal testimony of all parties is due this Wednesday, October 11, 2023.

The Division will ask Wanship to send its customers notice that a settlement agreement has been reached if such an agreement is achieved, and, if this motion is granted, provide notice of the scheduled hearings. Wanship has agreed to send such notice.

The Division requests that the Commission approve this Motion, and because the date for filing rebuttal testimony is today, requests expedited treatment of this Motion.
