WANSHIP WATER COMPANY, LLC'S REQUEST FOR A RATE INCREASE	Docket No. 23-067-01  Unopposed Motion to Approve Settlement Stipulation and Hold Hearings as Scheduled

Pursuant to R746-1 of the Public Service Commission of Utah's ("Commission") rules, the Division of Public Utilities ("Division") files this Unopposed Motion to Approve Settlement Stipulation and Hold Hearings as Scheduled ("Motion"). The Division is authorized to represent that Wanship Water Company, LLC ("Wanship") supports this Motion. There are no intervenors in this docket. The Division and Wanship ("the Parties") have engaged in fruitful settlement discussions that have resulted in the execution of the Settlement Stipulation filed contemporaneously with this Motion.

On October 11, 2023, the Division filed an Unopposed Motion to Vacate the Scheduling Order and Set New Date for Hearing and Public Witness Hearing and for Expedited Treatment requesting the Commission vacate the remaining deadlines for filing testimony and set November 1, 2023, as the new date for the hearing and public witness hearing. On October 12,

2023, the Commission issued its Order Granting Motion to Vacate Scheduling Order, Amended Scheduling Order, Notice of Hearing, and Notice of Virtual Public Witness Hearing (“Order”). The Order set forth an amended schedule for the docket that vacated the remaining testimony deadlines and set November 1, 2023, as the date for the hearing and virtual public witness hearing.

On October 13, 2023, Wanship provided to its customers notice of the proposed Settlement Stipulation and a link to the Commission’s website where the Settlement Stipulation and notice of the scheduled hearings can be found.

The Division requests that the Commission approve this Motion and hold both the hearing and virtual public witness hearing, per the Amended Schedule, on November 1, 2023, to consider the Settlement Stipulation. The Parties will provide witnesses at the hearing supporting approval of the Settlement Stipulation.
