The Division of Public Utilities (“Division”) has enclosed for filing with the Public Service Commission of Utah (“Commission”) Corrected Attachment 1 and Corrected Attachment 2, the redline and clean versions, respectively, of Wanship Water Company, LLC’s (“Wanship”) proposed tariff. These Corrected Attachments fix errors present in the original tariff versions, filed on September 27, 2023, with the Direct Testimony of Mark Long for the Division of Public Utilities as DPU Exhibit 3, Old and New Tariff – Redline, and DPU Exhibit 4, Final Clean New Tariff, and filed on October 17, 2023, with the Settlement Stipulation as Attachment 1, Wanship Water Company, LLC’s Tariff No. 3 – Redline, and Attachment 2, Wanship Water Company, LLC’s Tariff No. 3.

The included Corrected Attachment 1, the redline version of the tariff, changes “Tariff No. 31” to “Tariff No. 3” to correctly label page T1 and revises the effective date to be December 1, 2023, instead of December 15, 2023. The included Corrected Attachment 2, the clean version of the tariff, removes a draft tariff that was inadvertently included, which begins on the first cover page and ends on page T23, and changes the effective date from December 15, 2023, to December 1, 2023.
