Pursuant to R746-1 of the Public Service Commission of Utah's ("Commission") rules, the Division of Public Utilities ("Division") files this Unopposed Motion to Vacate the Scheduling Order Except for the Hearing and Public Witness Hearing Date and for Expedited Treatment ("Motion"). The Division is authorized to represent that WaterPro, Inc. ("WaterPro") supports this Motion. There are no intervenors in this docket.

The Division and WaterPro are engaging in fruitful settlement discussions and anticipate filing an executed settlement stipulation soon. Accordingly, the Division requests that the Commission vacate the schedule except for the hearings date and hold the in-person hearing and virtual public witness hearing on December 5, 2023, as scheduled. The Division also seeks expedited treatment of this Motion because rebuttal testimony of all parties is due next Tuesday, October 31, 2023.

The Division will ask WaterPro to send its customers notice that a settlement agreement has been reached if such an agreement is achieved, and, if this Motion is granted, provide notice of the scheduled hearings. WaterPro has agreed to send such notice.

The Division requests that the Commission approve this Motion, and because the date for filing rebuttal testimony is October 31, 2023, seeks expedited treatment of this Motion.
