ORDER GRANTING MOTION TO VACATE
SCHEDULING ORDER, AMENDED
SCHEDULING ORDER, NOTICE OF
HEARING, AND NOTICE OF VIRTUAL
PUBLIC WITNESS HEARING

ISSUED: October 30, 2023

On May 23, 2023, the Public Service Commission (PSC) issued a Scheduling Order, Notice of Hearing, and Notice of Public Witness Hearing ("Scheduling Order") in this docket. On October 27, 2023, the Division of Public Utilities (DPU) filed an Unopposed Motion to Vacate the Scheduling Order Except for the Hearing and Public Witness Hearing Date and for Expedited Treatment ("Motion to Vacate Scheduling Order"). DPU states it has been engaging in settlement discussions with WaterPro, Inc. ("WaterPro") and the parties anticipate filing a settlement stipulation soon. DPU asks the PSC to vacate the remaining deadlines for filing testimony set in the Scheduling Order. DPU requests the PSC hold the hearing and public witness hearing as scheduled for December 5, 2023. DPU states it is authorized to represent that WaterPro supports the Motion to Vacate Scheduling Order.

Good cause appearing, we grant the Motion to Vacate Scheduling Order as proposed. The amended schedule in this docket shall be as follows:
