Pursuant to R746-1 of the Public Service Commission of Utah’s (“Commission”) rules, the Division of Public Utilities (“Division”) files this Unopposed Motion to Vacate the Scheduling Order Except for the Hearing and Public Witness Hearing Date and for Expedited Treatment (“Motion”). The Division is authorized to represent that WaterPro, Inc. (“WaterPro”) supports this Motion. There are no intervenors in this docket.

The Division and WaterPro have engaged in fruitful settlement discussions and have reached a settlement resolving the issues in this docket. The Division has concurrently filed the executed settlement stipulation with this Motion.
