ORDER GRANTING MOTION TO VACATE  
THE SCHEDULING ORDER AND TO  
CONVERT EXISTING HEARING DATE TO  
CONSIDER SETTLEMENT STIPULATION

ISSUED: January 21, 2025

On January 16, 2025, the Division of Public Utilities (DPU) filed a Settlement Stipulation ("Settlement") and Unopposed Motion to Vacate the Scheduling Order Except for the Hearing and Public Witness Hearing Date and for Expedited Treatment ("Motion"). DPU represents it and WaterPro, Inc. ("WaterPro") have negotiated a stipulated agreement (i.e. the Settlement submitted contemporaneously with the Motion) that resolves all issues in this docket. In light of the Settlement, the Motion asks the PSC to vacate the existing Scheduling Order<sup>1</sup> while preserving the February 5, 2025, hearing and virtual public witness hearing for the purpose of receiving evidence and public comment regarding the Settlement.

DPU represents it is authorized to represent that WaterPro agrees to send its customers notice that the Settlement has been reached and, provided the Motion is granted, notice of the hearings to be held on February 5, 2025, regarding the Settlement.

As negotiated settlements are statutorily encouraged<sup>2</sup> and no opposition exists, the PSC grants the Motion. The Scheduling Order is vacated save for the hearing and virtual public witness hearing to be held on February 5, 2025, at 9:00 a.m. and 6:00 p.m., respectively, for purposes of considering the Settlement. The location of the hearing and instructions for participating in the virtual public witness hearing remain as noticed in the Scheduling Order.
