WaterPro, Inc.'s Application for Culinary Water Rate Increase	DOCKET NO. 25-2443-01 Unopposed Motion to Suspend Scheduling Order Except for Hearing Dates and Request for Expedited Consideration

The Utah Division of Public Utilities and WaterPro Inc. (respectively Division, WaterPro, and jointly the Parties) move the Public Service Commission of Utah (Commission) to modify the August 1, 2025, Scheduling Order, Notice of Hearing, and Notice of Public Witness Hearing in this docket by suspending all remaining deadlines except for the Hearing and Public Witness Hearing on January 27, 2026 (Motion). Because of the short period of time between the filing of this Motion and the January 6, 2026, deadline for filing rebuttal testimony, the Parties request expedited treatment of this Motion. The Division is authorized to represent that WaterPro supports this Motion. There are no other parties to this docket.

The Parties have been actively engaged in productive settlement negotiations and anticipate they will reach an agreement in principle soon which will be quickly followed by reaching and

filings a mutually acceptable Settlement Agreement. This process will require more time than the time available between the filing of this Motion and the January 6, 2026, deadline for filing rebuttal testimonies. The Parties anticipate that this process will be completed, and the Settlement Agreement filed ahead of the January 27, 2026, hearing dates in sufficient time to allow meaningful review by the Commission and interested others before the hearings.

Because of the short time between the filing of this Motion and the scheduled hearing dates and the unopposed nature of this Motion, the Parties request Expedited Consideration of this Motion.

For the reasons set forth above, the Parties respectfully request that the Commission suspend the Scheduling Order except for the hearing dates and consider this request expeditiously.
