ISSUED: January 4, 2006

By The Commission:

On December 20, 2005, the Commission issued a Notice of Hearing in Docket No. 05-019-01 scheduling a January 5, 2006, hearing before the Commission's Administrative Law Judge to consider the rate increase request filed by Wilkinson Cottonwood Mutual Water Company ("Wilkinson Water" or "Company") on February 1, 2005. The requested rates are contained in the Company's Proposed Tariff No. 1 attached to that request.

On December 22, 2005, Wilkinson Water filed an Amended Request for Rate Change including a Proposed Tariff No. 2 containing requested rate increases in addition to those originally requested in the Company's February 1, 2005, filing. This Amended Request was assigned Docket No. 05-019-T01.

On January 3, 2006, the attorney for the Division of Public Utilities ("Division") advised the Administrative Law Judge that the Division and Wilkinson

Water have agreed to postpone the January 5, 2006, hearing pending further discussion between the Division and Company regarding the Company's December 22, 2005, filing. In addition, Division personnel indicate the parties intend to meet to discuss this filing on January 18, 2006.

Given that the Company's filing of December 22, 2005, effectively subsumes its earlier filing in Docket No. 05-019-01, the Commission determines to close Docket No. 05-019-01 with no further action and to adjudicate the requested rate increase under Docket 05-019-T01. Therefore, **notice is hereby given that the hearing previously scheduled to commence in Docket No. 05-019-01 at 9:00 a.m. on Thursday, January 5, 2006, is canceled.**

In order to facilitate timely adjudication of the matters at issue in Docket No. 05-019-T01, the Commission requests the Division advise the Administrative Law Judge of the status of its investigation in Docket No. 05-019-T01 not later than January 31, 2006, so that further proceedings can be scheduled as appropriate.
